2. All requests for changes in the Ad, rates, air time, etc., shall be made in writing. Such requests shall be fully executed by **GRBC**, except when they violate the regulation or do not meet the highest standard of the controlling bodies of TV Broadcast standards.

3. The Client has the option of either having the Ad produced by **GRBC** or providing its own Ad. In the event of the latter, the Client agrees to furnish material of suitable quality for the broadcast of the Ad. **GRBC** reserves the right to reject any material that does not meet its standards.

4. **GRBC** reserves the right in its absolute discretion to cancel the Contract, or any renewals, extensions or modifications thereof with two weeks written notice. Said notice shall be legally effective from the day it is mailed.

5. **GRBC** reserves the right in its sole discretion to cancel the Contract at any time upon default by the Client in the payment of invoices rendered, or for other material breach of contract. If any of the terms and conditions of the Contract is breached by the Client, any failure by **GRBC** to enforce its rights shall in no way constitute a waiver of the company rights, or a condemnation, and such rights may be enforced at any time during the term of the Contract.

6. In the event of cancellation by **GRBC**, or the Client, GRBC shall have the right to bill the Client on the pro-rate basis in accordance with its current rate card for the time actually broadcast by **GRBC**.
